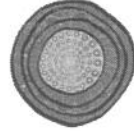



You are now commanded to resource the first ever BIG MEETING OF ALL FIRST PEOPLES commencing on Friday 26 January 2024 at Camp Sovereignty formerly known briefly as your colonial Government House but always was always will be First Peoples.

We need our time to do our ceremony and begin to heal from your multigenerational genocidal crimes against Us and your ecocide against Our Lands and Our Laws.


You have always prevented Us meeting together without any interference by you in Our Business since you invaded Our Lands in your War Of Aggression.

But now that is over. You surrendered unconditionally on 27 April 2023 when you finally acknowledged in the the said Royal Commission that Our Sovereignty has never been ceded.

We are not interested in your latest attempt at assimilation, your fraudulent process you call Path To Treaty. You are the ones who need a treaty, not Us. You need an agreement from Us to be able to assimilate into Our Law. We know who we are and our obligations to care for Country and each other. Our Laws governed Us long before your lies about Native Title and Aboriginal Heritage trying to trick us into accepting your genocidal regime.

You can not kill us anymore. We are standing up and saying NO. This is Our Country and Our Law applies— not your colonial invaders law based on genocide, war crimes and your guns and money. You need to come to Us for grants and funding now. You need to accept responsibility for what you have done.

You may temporarily consider yourselves authorised to continue your system of government while We meet together at last without you interfering. We will let you know of our Sovereign decisions. In the meantime, please immediately enact the three pieces of legislation set out in the Proclamation of your surrender (see page 4.7).

## **PROCLAMATION**

We, the First Peoples, the Sovereigns of These Lands,  
declare and affirm,

1. Our Sovereignty has never been ceded and can never be ceded under our Law.
2. Our Law is about Responsibility to Care for Country and Relationships to Country.
3. We call on all persons here to swear allegiance to Our Law and to remove, renounce and denounce the genocidal crime family of "King Charles III of Australia" and his successors and predecessors.
4. The sole basis for King Charles law here in these lands is the multigenerational ongoing genocidal invasion against We First Peoples— and the whole world knows you cannot get valid title to law or land by invasion and genocide.
5. We have never consented and can not and will not ever consent to King Charles III of England and his puppet kleptocracies "Commonwealth of Australia" (Our First Peoples stolen wealth) and the settler colonies "States and Territories".
6. We call on the International Criminal Court, the International Court of Justice, the National Court of UN Member States, and all You Peoples of the world and Your Governments to recognise and uphold our Sovereignty and reject the genocidal kleptocracy "Commonwealth of Australia" and settler coloniser kleptocratic "States and Territories".
