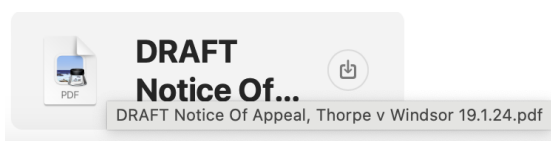
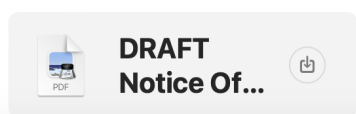

TAKE NOTICE that the Appellant seeks to appeal to the Supreme Court of Victoria pursuant to section 272 of the Criminal Procedure Act 2009 (Vic)] against the judgment given and final order made by Chief Magistrate Hannan (or Deputy Chief Magistrate Wakeling or Deputy Chief Magistrate Bourke— it is unclear who made the order as set out below) on Monday 23 October 2023 (earliest date order was made but it is unclear as set out below— it could be any date between 23 October 2023 and 1 November 2023).

ORDER SUBJECT TO APPEAL:

**No order has been published.**

**From subsequent events it would appear that at some time on or after 23 October 2023 and 29 December 2023 the Chief Magistrate (or one of the two Deputy Chief Magistrates)(or possibly even the Principal Registrar or a Senior Registrar) made an order that:**

1. The request made by Robert Thorpe in his letter to the Chief Magistrate dated 20 October 2023 for an appointment with the Chief Magistrate is refused.
2. The request made by Robert Thorpe to the Chief Magistrate in the said letter for leave to file documents to initiate cases through the eDocs portal and to be provided with login access to the eDocs portal is refused.

3. The request of Robert Thorpe for the Chief Magistrate to exercise the powers of a Registrar and receive the Charge Sheet attached to the said letter and arrange for it to be filed and listed for a committal hearing is refused.
4. The proper source of the law has not been particularised in the charge sheet and summons.
5. The proposed accused may be misled or otherwise prejudiced by this omission.
6. The issue of the proceeding would be an abuse of process.
7. The proceeding not be issued.

#### QUESTIONS OF LAW:

1. Whether a Chief Magistrate is obliged to make an appointment for a self-represented person to attend and request leave to file documents to initiate cases through the eDocs portal and to be provided with login access.
2. Whether a Chief Magistrate is obliged to grant leave to a self-represented person to file documents to initiate cases through the eDocs portal and to be provided with login access.
3. Whether a Chief Magistrate in all the circumstances to exercise the powers of a Registrar and receive the Charge Sheet attached to the said letter and arrange for it to be filed and listed for a committal hearing.
4. Whether the original law of this land at all times prohibits conduct by First Peoples and others on country constituting the offence of genocide as articulated in the 1948 UN Genocide Convention and the offence of ecocide as articulated by the expert legal group in submissions to expand the jurisdiction of the International Criminal Court.
5. Whether the common law of the State of Victoria at at 20 October 2023 prohibits not only murder but also genocide as articulated in the 1948 UN Genocide Convention.
6. Whether the statutory law of the Commonwealth of Australia has prohibited genocide for the past two decades in Division 268 of the Criminal Code Act and whether the statutory prohibition on anyone but its Attorney-General prosecuting the offence is unconstitutional.

#### THE GROUNDS RELIED UPON ARE:

1. Rules of natural justice— right to a hearing by decision maker, right to equality of treatment.
2. Provisions of Victoria’s Equal Opportunity Act and Commonwealth Racial Discrimination Act as specifically referred to by Robert Thorpe at paragraph 3 of the letter dated 20 October 2023..
3. Policy of said legislation.
4. Policies of the Court, the Courts Council and the State of Victoria in relation to righting the wrongs of the past towards First Peoples such as those set out in paragraph 6 placate (i), (ii) and (iii) in the letter of Robert Thorpe dated 20 October 2023 to the Chief Magistrates (Hannan, Wakeling & Bourke).

5. The gravity of the charges, the complexity of the evidence and the unprecedented legal issues required the leadership and responsibility of the Chief Magistrate not a Manager Of Operations Registrar or a Senior Registrar.
6. The proper source of the law is the original law of the land prohibiting First Peoples from actions amounting to genocide and ecocide.
7. Another proper source of law is the common law of the UK monarchy's colony known as State of Victoria which as at October 2023 prohibits genocide as well as murder.
8. Another proper source of law is the statute law of the UK monarchy's federated colonial entity Commonwealth of Australia which has prohibits genocide under Division 268 of its Criminal Code Act for the past two decades.
9. These three sources of the law listed in the paragraphs numbered 6, 7 and 8 above were set out in a detailed memo accompanying the charges on 20 October 2023 as were the complex factual history of the offences

#### ORDER SOUGHT:

1. Chief Magistrate to make appointment time and date for Robert Thorpe to appear and seek leave to initiate cases through the eDocs portal and to be provided with login access to the portal (as per Robert Thorpe written request in letter dated 20 October 2023 with subject 'Exclusion of self-represented parties from the implementation of eDocs')

or

1. [*in the alternative*] Leave is granted to Robert Thorpe to initiate cases through the eDocs portal and to be provided with login access to the portal.
2. Chief Magistrate to exercise the powers of a Registrar to receive the Charge Sheet attached to the said letter and arrange for it to be filed and listed for a committal hearing.
3. Chief Magistrate to provide details of which Officers of the Court, the Courts Council and the State of Victoria and the Commonwealth of Australia were provided with the documents delivered to the court on 20 October 2023 and the dates of such provision and any advice written or oral provided by the said officers.

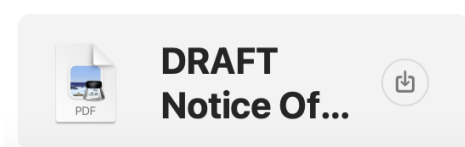
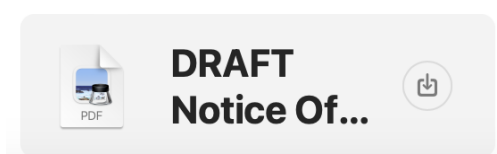

Re: Resourcing for First Peoples' Genocide Claim— Thorpe v Windsors, UK, Victoria, Australia.

I refer to the document **Evidence 10** of Robert Thorpe in the Yoorrook Royal Commission, Friday 22 December 2023<sup>6</sup> delivered to your King Charles III by international express post on Monday 25 December 2023.<sup>7</sup> Note pages 7 to 16 —as well as **Evidence 1 to Evidence 9** at pages 54 to 70.

As a victim of your genocide (genocide of First Peoples here by your royal monarchic crime family and your three kleptocratic governments and officials of UK, Victoria and Australia), I require access to top international legal resources to formulate and submit my genocide claim to the Windsors, the UK, State of Victoria and Commonwealth of Australia on behalf of certain First Peoples (myself, my families and the several other First Peoples my families are connected with).

There will also be an ecocide claim for destruction of country.

I require each of the four numbered parties above to commit forthwith to each paying \$250,000.00 of my future legal bills (up to \$1 million in total) incurred in this matter.

I intend initially to engage some local firms of Aboriginal solicitors to brief Geoffrey Robertson, Jennifer Robinson, Amal Clooney and Kathryn O'Byrne of Doughty St Chambers in London and Tony McEvoy of Jordan Chambers in Sydney to advise on other counsel and firms with relevant areas of expertise.

I expect that many other First Peoples will also require similar assistance in resourcing legal expertise to formulate Genocide Claims and Ecocide Claims.

I expect that We will require further commitments from the four parties (Windsors, UK, Victoria, Australia) to pay further legal bills in formulating Our Genocide and Ecocide Claims.

It should be obvious that until these fundamental truth-telling claims are properly formulated by First Peoples and admitted by the four parties that no peace treaties can be negotiated to clarify the basis on which non-First-Peoples may be permitted by First Peoples to remain on Our Lands.

It should also be obvious that the four parties should declare immediately an end to all hostilities against First Peoples and an end to any coercive control of First Peoples.

Please do me the common courtesy of acknowledging receipt of this memo by return email.

NOTE:

(i) A copy of this email appears in Evidence 11 of Robert Thorpe to Yoorrook Justice Commission, Friday 29 December 2023.

(ii) Copies of this document and all documents referred to herein (Evidence 1 to Evidence 10) will be included in the brief to the Prosecutor of the International Criminal Court and in the materials to be provided to the International Court of Justice— as well as to national courts of UN Member States.

(iii) All nations at one time occupied by British imperial forces and still said by the Windsors and the UK to be part of "the Commonwealth" will also be briefed in detail on these developments.
