4. I refer to my my originating motion for judicial review of the decision of the Attorney-General of Victoria in said NCR486877 seeking an order that Hon. Sonya Kilkenny MP consult in terms of paragraph 10 of my Form 64B application dated 26 March 2025 and submitted the same day for filing.

5. I refer to New Case Request 486453 lodged at 2.41pm on 24 March 2025 and being reviewed by Anna D since 10.27am on 25 March 2025 being the Form 64B application of honorary doctor Aunty Alma Thorpe for leave to intervene in this application for leave to appeal. I am grateful for her intervention, like the whole Aboriginal community who respects her as a distinguished Elder. Dr Aunty Alma's contribution as an intervenor is especially welcomed because it will be useful and different from the contribution of the parties.

6. Upon the court accepting my Form 64B application dated 26 March 2025 and submitted for filing herewith I will submit a further affidavit with further supporting details in relation to each of the 13 orders sought.

7. I refer to the directions hearing before Judicial Registrar Pedley on 18 March 2025 and the orders of the Court of Appeal made by him on the same day. I received no prior notice of this directions hearing and the orders were made without the opportunity for me to attend and appear in the matter. The Court's orders are said to be "BY CONSENT" but this is not true. I was never there, never given an opportunity to be there and in any event there is no evidence by transcript or otherwise that I gave any prior, informed consent to these orders. In particular I do not consent to Order 2 that the requirement of a summary for the Court of Appeal be dispensed with.


