New Case Request 489210 pending assessment in Supreme Court of Victoria 2 April 2025

This morning at 10.15 I lodged an originating motion for judicial review of Commissioner Ro Allen's decisions yesterday not to

- (i) sign Our declaration document,
- (ii) add Our wording to every Commission webpage,
- (iii) arrange an urgent conciliation with Supreme Court CEO Michael Carroll of our complaint lodged with the Commissioner at 9.07am on 1 April 2025,
- (iv) make an application to intervene in my three genocide cases in the Court of Appeal including the King Charles Aboriginal Genocide case.

The motion seeks two orders from the Court:

1. that the Commissioner did and does have the power to do each of those four actions and
2. that the Commissioner should consider doing and do each of those four actions.

In addition to VEOHRC, the motion names three other defendants whose presence before the court is "necessary to ensure that all questions in the proceeding are effectually and completely determined and adjudicated upon" within the meaning of Rule 9.06(b)(i) of the *Supreme Court (General Civil Procedure) Rules 2015*:

First Defendant VICTORIAN EQUAL OPPORTUNITY AND HUMAN RIGHTS COMMISSION
Second Defendant ATTORNEY-GENERAL OF VICTORIA
Third Defendant AUSTRALIAN COUNCIL OF HUMAN RIGHTS AUTHORITIES
Fourth Defendant UNITED NATIONS HUMAN RIGHTS COUNCIL

Please find attached a pdf file of the court's electronic filing receipt Pending assessment together with all four documents lodged at 10,15am this morning-- form 5G originating motion, form 4A certificate, form 4B certification and 41-page affidavit of Uncle Robbie Thorpe affirmed 2 April 2025.

Please note that these documents have NOT been accepted by the court but nor have they been rejected.

However they do set out the facts and issues involved with some timely clarity.

In relation to my complaint lodged yesterday morning (9.07am 1 April 2025) with the Commissioner, I again request the Commission to urgently arrange a conciliation/mediation/meeting between the two parties-- SCV CEO Michael Carroll and Uncle Robbie Thorpe-- today if possible please.

In relation to your intervening in the Court of Appeal, I again ask the Commission to consider and to make the relevant Form 64B application with the five documents I provided yesterday morning 1 April 2025 at 10.25am and reproduced in Exhibit "URT 1" to my said affidavit at pages 22-39.
