Final Notice dated 25/12/25 to vacate your Trespassers Camp by 26/1/26 Invasion Day.

TO:

All persons at the Trespassers Camp including persons calling themselves fanciful titles such as "Her Excellency", "His Majesty", "Official Secretary", etc. namely:

1. Margaret Elaine Gardner (self-described as "Thirtieth Governor of Victoria"), and
2. Charles Mountbatten Windsor (self-described "King of Australia, Antigua and Barbuda, The Bahamas, Belize, Canada, Grenada, Jamaica, New Zealand, Papua New Gunea, Saint Kitts and Nevis, Saint Lucia, Saint Vincent and the Grenadines, Solomon Islands, Tuvalu"), and
3. Jonathan Burke (self-described "Official Secretary of the Office of the Governor OOG"), and
4. Patrick Rundle (self-described "Deputy Official Secretary"), and
5. Deborah Nicolson (self-described "Community Engagement Adviser"), and
6. Glyn Conrad Davis (spouse of said Gardner and "Secretary of the Department of the Prime Minister and Cabinet of Australia"), and
7. others whose names are not known.

You are hereby given one month's notice to vacate the Trespassers Camp and to remove everything including:

(i) all your effigies of a lion (non-native)and a unicorn (non-real); and

(ii) all your genocidal "archives" including the directive by Charles La Trobe ("First Governor of Victoria") to remove all Aboriginal Peoples from the Melbourne area by any means necessary -- see <https://www.yoorrook.org.au/history/victorias-history-to-now> --and subs-quent enforcement orders the same year relating to the mass arrest and imprisonment of hundreds of Indigenous people during an event known as the "Lettsom raid" near Camp Sovereignty; and

(iii) all "Trespassers will be prosecuted" signage you have placed on the walls you have erected around your Trespassers Camp; and

(iv) all your armed guards and all guns and weapons whether those used in previous massacres of Aboriginal Peoples or not.

Dear Uncle Robbie,

We refer to your email below.

We contacted you by telephone this morning to discuss the request for an adjournment as it is our usual custom in these matters to contact parties by phone to discuss matters of this nature, in the interests of time. We apologise for any inconvenience it may have caused. We note your request that all future communications be in writing and we have no issue with this.

As you are aware, we are the legal representative for the Governor and our communications with her are privileged, which means they cannot be shared. This also means that we cannot provide you with legal advice. However, we note that an administrative adjournment means an adjournment done by way of email between the parties and the court (rather than requiring an appearance in court).

We advise that the adjournment is being sought as more time is required due to the complexities of the matter.

Will Yates is the Assistant Victorian Government Solicitor supervising this matter and he will be the contact person on this matter whilst I am on leave as of today until 12 January 2026.

Given the time constraints due to the holiday period and the need for us to seek instructions in relation to some of your questions, we will respond to your remaining questions in the new year.

Further, in order to allow you time to obtain legal advice with respect to our request for an administrative adjournment (if you wish), we are happy to postpone making the application for an adjournment until the week beginning 5 January 2026.

I refer to my emails to VGSO on 17 November 2025 and 19 December 2025 reproduced below and your sole response on 19 December 2025.

At about 10am this morning, you telephoned me and introduced yourself as Maria Macri from the Government Solicitor's office acting on behalf of the Governor and stated you wanted to adjourn the case until 26 February 2026.

You asked if I would agree to this and I asked you to put that in writing with your name and I would get back to you.

I now refer to your email to me at 10.11am this morning requesting agreement by 1pm today.

In order to consider your request could you please clarify the matter by responding to these nine questions within the hour or at least by 12.57pm today.

1. What is an "administrative" adjournment-- are there non-administrative adjournments and how do they differ from the one you seek?

2. Why are you seeking the adjournment? What are your reasons?

3. Why are you suddenly seeking the adjournment this morning in the final few hours before the Christmas break when you have had two months to seek an adjournment?

4. Why did you telephone me rather than writing to me so that there is no doubt about exactly what is said by the accused's legal representative and myself as the self-represented Aboriginal informant?

5. Do you agree that all further communication be done in writing and you will make no further unsolicited phone calls to me?

6. Did the accused personally instruct you to telephone me and to seek this adjournment?

7. If you are not receiving instructions personally from the accused, who is the accused's representative that instructed you to phone me and to suddenly seek this adjournment?

8. Who is Will Gates at VGSO you have ccd?

9. Does the accused have any interest in entering a guilty plea to the trespass charge at the first available opportunity and meeting with me prior to 23 January 2026 to draft a joint statement on the cessation of hostilities against Our Peoples and a peace treaty ending the war against Our Peoples and a program for the recovery of Our Lands and respect for Our Law and associated reparations, restorations and restitutions?

Please find attached two unissued witness summons for your consideration.

The summons are addressed to two of the four uniformed officers served at the gatehouse of Government House on Wednesday 12 November 2025 to prove proper service upon the accused.

No response has been received to the informant's request a month ago on Monday 17 November 2025 to the accused via the Attorney-General ("AGV"), the Victorian Government Solicitor's Office ("VGSO") and Official Secretary Jonathan Burke at the Office of the Governor ("OOG") to acknowledge proper service was made. (Relevant correspondence reproduced below).

This service thus appears to be in contention.

Would you consider issuing the two summons now with a return date of the first mention on Friday 23 January 2026 so that the two officers can be served soon and arrangements made for their attendance on that date should there be no appearance by the accused?
