1. On 24 December 2025 the accused requested an adjournment "as more time is required due to the complexities of the matter" and I confirm the informant's written consent given on 5 January 2026 to the adjournment.

2. The agreed court date is now **Friday 27 February 2026** at Melbourne Magistrates' Court.

3. Please refer to my Form 5E Originating Motion for Recovery of Land under Order 53 Summary Proceeding for Recovery of Land as lodged in the Supreme Court of Victoria on 28 March 2025 **New Case Request eFile ID 488053** delivered to the accused on 12 November 2025 along with service of the Trespass Charge as set out in the informant's Form 6A Affidavit Of Service lodged in the Magistrates' Court on 17 November 2025.

4. Please note my **Final Notice dated 25 December 2025** (reproduced below) to vacate the Trespassers Camp within 30 days by Invasion Day, 26 January 2026, as delivered to the accused and the accused's legal representatives-- solicitors O'Brien, Murphy, Yates, Andrade, Leggiero-- on 25 December 2025. (Note that Professor Glyn Davis referred to in the said Final Notice as "Chief of Staff to the Prime Minister and Cabinet of Australia" apparently retired from that position on 16 June 2025 having served in that position for three years from 6 June 2022.)

Final Notice dated 25/12/25 to vacate your Trespassers Camp by 26/1/26 Invasion Day.

TO:

All persons at the Trespassers Camp including persons calling themselves fanciful titles such as "Her Excellency", "His Majesty", "Official Secretary", etc. namely:

1. Margaret Elaine Gardner (self-described as "Thirtieth Governor of Victoria"), and
2. Charles Mountbatten Windsor (self-described "King of Australia, Antigua and Barbuda, The Bahamas, Belize, Canada, Grenada, Jamaica, New Zealand, Papua New Gunea, Saint Kitts and Nevis, Saint Lucia, Saint Vincent and the Grenadines, Solomon Islands, Tuvalu"), and
3. Jonathan Burke (self-described "Official Secretary of the Office of the Governor OOG"), and
4. Patrick Rundle (self-described "Deputy Official Secretary"), and
5. Deborah Nicolson (self-described "Community Engagement Adviser"), and
6. Glyn Conrad Davis (spouse of said Gardner and "Secretary of the Department of the Prime Minister and Cabinet of Australia"), and
7. others whose names are not known.

You are hereby given one month's notice to vacate the Trespassers Camp and to remove everything including:

- (i) all your effigies of a lion (non-native) and a unicorn (non-real); and
- (ii) all your genocidal "archives" including the directive by Charles La Trobe ("First Governor of Victoria") to remove all Aboriginal Peoples from the Melbourne area by any means necessary -- see <https://www.yoorrook.org.au/history/victorias-history-to-now> --and subs-quent enforcement orders the same year relating to the mass arrest and imprisonment of hundreds of Indigenous people during an event known as the "Lettsom raid" near Camp Sovereignty; and
- (iii) all "Trespassers will be prosecuted" signage you have placed on the walls you have erected around your Trespassers Camp; and
- (iv) all your armed guards and all guns and weapons whether those used in previous massacres of Aboriginal Peoples or not.
