Upon the Court of Appeal being satisfied that

- (a) the applicant's contribution as an intervener will be useful and different from the contribution of the parties and
- (b) that the intervention would not unreasonably interfere with the conduct of the application or appeal; and
- (c) of any other matter that the Court of Appeal considers relevant

the Court grants leave pursuant to r 64.10 of the *Supreme Court (General Civil Procedure) Rules 2015* to

Dr Aunty Alma Thorpe

to intervene in the applications for leave to appeal of Uncle Robbie Thorpe filed 28 February 2025 in proceedings S EAPCI 2025 0023 and filed 9 August 2024 SEAPCI 2024 0091

to appear in person at the bar table and address any matter (unless the court extemporaneously withdraws leave to address certain matters) and make submissions both oral and in writing with no undertaking as to costs.

This application is made on the following grounds:

1. AGE

I will be 90 years old on 31 March 2025 and there are not many of Us who can say that.

2. RECOGNISED EXPERIENCE

I have just been awarded an honorary doctorate<sup>2</sup> by Victoria University as a health worker and lifelong activist for Our People and am a senior Elder respected by the whole Aboriginal community and my advice is sought and listened to regularly.

I was a key witness at the Yoorrook Justice Commission on the genocide against Us by the Half-Caste Act and forced assimilation (providing both oral testimony and a detailed written witness statement) and lodged a writ on Monday 24 March 2025 to get this forced assimilation acknowledged as genocide in any so-called treaty that eventuates with the State of Victoria.

### 3. SELF-REPRESENTED LITIGANT

I signed the Caring For Country Proclamation dated 27 April 2023, the day the State of Victoria admitted formally acknowledged to Commissioners at the hearing in the State's own Yoorook Justice Commission that Our Sovereignty has never been ceded, calling for the State to legislate

- (i) the *First Peoples Sovereignty (Recognition) Act 2023*,
- (ii) the *UN Declaration of the Rights of Indigenous Peoples Act 2023* and
- (iii) the *UN Convention on the Prevention and Punishment of the Crime of Genocide Act 2023*.

I signed the genocide charge on 20 October 2023 against Charles Philip Arthur George Windsor as Elder and sought a direction in the subsequent judicial review proceedings in the Supreme Court that I be named principal plaintiff in those proceedings as Elder (summons filed 15 March 2024 SCV eFile ID 395803)

I refer to the Care For Country Proclamation two months later on International Human Rights Day, 10 December 2023, addressed to

- (i) Prosecutor of International Criminal Court
- (ii) Judges of International Court of Justice
- (iii) National Courts of UN Member States
- (iv) All you Peoples Of The World and Your Governments.

Upon being disrespectfully rebuffed as principal plaintiff on Monday 22 April 2024 (lower court transcript page 26 line 9 to page 30 line 26) I began my own legal proceedings four days later by lodging a writ as principal plaintiff on ANZAC Day, Thursday 25 April 2024 (said writ reproduced in part in annexure "A" to my writ lodged 24 March 2024).

When that too was rejected from filing, I filed an application for leave to appeal (2 August 2024, CA 88/24) which I expect will be heard together with this King Charles appeal and the other appeal filed 9 August 2024 (CA 91/24) concerning the Supreme Court's power and duty to have a specialist Aboriginal Genocide List (aka "Aboriginal Genocide Court"). in both Criminal and Civil Divisions of the Court
